For the first time, the international conference and pre-conference workshop of this magnitude is being organized. The theme of the three-day fiesta has been thought out and carefully chartered by the biggest players and contributors in the field of Pharmacovigilance and Pharmacoeconomics, namely- Delhi Institute of Pharmaceutical Sciences and Research (DIPSAR), Society for Pharmacoeconomics and Outcomes Research-India chapter, Society for Pharmacovigilance India, Indian Pharmacopoeia Commission (IPC) that have been brought together under the umbrella of Delhi Pharmaceutical Sciences and Research University (DPSRU), for the benefit of students, industry academia and regulatory bodies.

DIPSAR has strong legacy of 54 years. It started as the college of pharmacy in 1964, upgraded to research institute in 2004, (Delhi Institute of Pharmaceutical Sciences & Research) and has got the status of the constituent college of the Delhi Pharmaceutical Sciences and Research University.
